A valuable collection of up-to-date information by leading international experts The history of rotator cuff tendinopathy started more than 150 years ago, when some types of shoulder pain were attributed to rupture of the rotator cuff tendon'. In the third millennium, the pathogenetic mechanisms leading to rotator cuff problems are still debated. Although conservative measures are the first-line therapy, poor spontaneous tendon healing and progression from partial- thickness to full-thickness tears may mandate surgery. Biological, biomechanical and clinical studies have been conducted to establish the superiority of one technique over the other, but no clinical differences have been found. Although we know more about the pathogenesis, diagnosis and management of rotator cuff pathology, our efforts should be directed at trying to find the treatment that best fits the specific needs of each patient. This book collects current reviews on rotator cuff problems, with regard to both biological and clinical aspects, and provides practical hints on management and rehabilitation for sports physicians, surgeons, physiotherapists and athletic trainers.

Professor Vincenzo Denaro has been an active member of the Institute of Clinical Orthopedics and Traumatology of the University of Catania since 1986. It has been my pleasure, as Director, to be associated with Professor Denaro, first as a Sessional Consultant in diseases of the spine and finally, after his promotion to the permanent staff, as Associate Professor. Professor Denaro began his postgraduate program of specialization, and hence his career, in the Orthopedic Clinic of the University of Pavia under the tutorship of Professor Mario Boni. It was the latter who directed and guided his development in studying the disease processes of the vertebral column. In his pursuit of knowledge, he undertook additional studies in foreign clinics, including the Wellesley Hospital at the University of Toronto with Professor I. MacNab and Professor V. Fornasier. He spent a full year at the Orthopedic Clinic of the University of Paris under the guidance of Professor Roy Camille. He derived great benefit from the clinical experience gained there and became acquainted with advanced and specialized surgical techniques specific to his field of interest. More recently, since accepting his current appointment, he has been able to put into practice the expertise developed over 20 years of study and research. Not only does he have extensive personal clinical experience, but he very wisely undertook to maintain a thorough, complete, and accurate record of the experience gathered from his case load.

The nexus between terrorism and organised crime consists of a strategic alliance between two non-state actors who are able to exploit illegal markets, threaten the security of individuals, and influence policy-making on a global level. The articles in the second section analyse different aspects of monetary production and circulation in Byzantine Italy, while the third gathers together studies on various aspects of Carolingian coinage: the transition from the Lombard system and the problem of furnishing an adequate supply of silver; mints and royal administration; and the activity and inactivity of mints operating at the edges of the *Regnum Italiae*. All of the articles share the author's characteristic concern with setting the evidence from written sources against the wealth of new data emerging from recent archaeological research.

The Economy of Renaissance Florence

This volume brings together a series of studies by Professor Blomquist on the evolution of banking in Lucca from the 12th and 13th centuries. They describe how the leading bankers operated, how they invested, and how they pursued their family interests. In particular, they trace the transformation of money changers, or campsores, into deposit and transfer bankers, who deployed their capital in trading ventures as well as in banking. Moreover, the author shows how Lucchese merchant-bankers expanded their operations from Italy, first to the fairs of Champagne and ultimately to all of Europe's major commercial centres. Special attention is given to the use of the exchange contract, or cambium, as an instrument of credit and of transfer. Problems of coinage and foreign exchange are also treated extensively, including the origins of the Tuscan grossi and the Lucchese gold groat. The collection concludes with a study of the cloth trade and another concerning the first consuls in Lucca.

English Travellers and Italian Brigands a Narrative of Capture and Captivity by W.J.C. Moens

THE TRUE CRIME CULT CLASSIC: Follow journalist Maury Terry's decades-long investigation into the terrifying truth behind the murders of serial killer Son of Sam. Inspired the Netflix docuseries The Sons of Sam: A Descent into Darkness! On August 10, 1977, the NYPD arrested David Berkowitz for the Son of Sam murders that had terrorized New York City for over a year. Berkowitz confessed to shooting sixteen people and killing six with a .44 caliber Bulldog revolver, and the case was officially closed. Journalist Maury Terry was suspicious of Berkowitz's confession. Spurred by conflicting witness descriptions of the killer and clues overlooked in the investigation, Terry was convinced Berkowitz didn't act alone. Meticulously gathering evidence for a decade, he released his findings in the first edition of The Ultimate Evil. Based upon the evidence he had uncovered, Terry theorized that the Son of Sam attacks were masterminded by a Yonkers-based cult that was responsible for other ritual murders across the country. After Terry's death in 2015, documentary filmmaker Josh Zeman (Cropsey, The Killing Season, Murder Mountain) was given access to Terry's files, which form the basis of his docuseries with Netflix and a companion podcast. Taken together with The Ultimate Evil, which includes a new introduction by Zeman, these works reveal the stunning intersections of power, wealth, privilege, and evil in America—from the Summer of Sam until today.
