## Bulletin

This unique reference, aimed at research topologists, gives an exposition of the 'pseudo-Anosov' theory of foliations of 3-manifolds. This theory generalizes Thurston's theory of surface automorphisms and reveals an intimate connection between dynamics, geometry and topology in 3 dimensions. Significant themes returned to throughout the text include the importance of geometry, especially the hyperbolic geometry of surfaces, the importance of monotonicity, especially in 1-dimensional and co-dimensional dynamics, and combinatorial approximation, using finite combinatorial objects such as train-tracks, branched surfaces and hierarchies to carry more complicated continuous objects.

## Foliations and the Geometry of 3-Manifolds

This book constitutes the proceedings of the 8th International Conference on Algorithms and Discrete Applied Mathematics, CALDAM 2022, which was held in Puducherry, India, during February 10-12, 2022. Chapter 3 addresses the design of the racing chassis design and how aerodynamics affect the chassis, and the final chapter on materials brings out the fact that the modern racing car utilizes carbon construction to the maximum extent allowed by regulations. These technical papers, written between 1971 and 2003, offer what Smith believed to be the best and most practical nuggets of racing chassis and suspension design information.

The approach to classical mechanics adopted in this book includes and stresses recent developments in nonlinear dynamical systems. The concepts necessary to formulate and understand chaotic behavior are presented. Besides the conventional topics (such as oscillators, the Kepler problem, spinning tops and the two centers problem) studied in the frame of Newtonian, Lagrangian, and Hamiltonian mechanics, nonintegrable systems (the Hénon-Heiles system, motion in a Coulomb force field together with a homogeneous magnetic field, the restricted three-body problem) are also discussed. The question of the integrability (of planetary motion, for example) leads finally to the KAM-theorem. ## **A Modern Approach to Classical Mechanics**

The search for a quantum theory of the gravitational field is one of the great open problems in theoretical physics. This book presents a self-contained discussion of the concepts, methods and applications that can be expected in such a theory. The two main approaches to its construction -- the direct quantisation of Einstein's general theory of relativity and string theory -- are covered. Whereas the first attempts to construct a viable theory for the gravitational field alone, string theory assumes that a quantum theory of gravity will be achieved only through a unification of all the interactions. However, both employ the general method of quantization of constrained systems, which is described together with illustrative examples relevant for quantum gravity. There is a detailed presentation of the main approaches employed in quantum general relativity: path-integral quantization, the background-field method and canonical quantum gravity in the metric, connection and loop formulations. The discussion of string theory centres around its quantum-gravitational aspects and the comparison with quantum general relativity. Physical applications discussed at length include the quantization of black holes, quantum cosmology, the indications of a discrete structure of spacetime, and the origin of irreversibility. This third edition contains new chapters or sections on quantum gravity phenomenology, Horava-Lifshitz quantum gravity, analogue gravity, the holographic principle, and affine quantum gravity. It will present updates on loop quantum cosmology, the LTB model, asymptotic safety, and various discrete approaches. The third edition also contains pedagogical extensions throughout the text. This book will be of interest to researchers and students working in relativity and gravitation, cosmology, quantum field theory and related topics. It will also be of interest to mathematicians and philosophers of science.
