Finding Your Roots, Season 2

Who are we, and where do we come from? The fundamental drive to answer these questions is at the heart of *Finding Your Roots*, the companion book to the hit PBS documentary series. As scholar Henry Louis Gates Jr. clearly demonstrates, the tools of cutting-edge genomics and deep genealogical research now allow us to learn more about our roots and look further back in time than ever before. In the second season, Gates's investigation takes on the personal and genealogical histories of more than twenty luminaries, including Ken Burns, Stephen King, Derek Jeter, Governor Deval Patrick, Valerie Jarrett, and Sally Field. As Gates interlaces these moving stories of immigration, assimilation, strife, and success, he provides practical information for amateur genealogists just beginning archival research on their own families' roots and details the advances in genetic research now available to the public. The result is an illuminating exploration of who we are, how we lost track of our roots, and how we can find them again.

Without Roots

On May 12, 2004, Pope Benedict XVI - then Cardinal Joseph Ratzinger-addressed the Italian Senate on the state of the West; the very same day, Joseph Pera, President of the Italian Senate, spoke before the Lateran College of the Papal University. Together they called upon the West to confront the spiritual, cultural, and political malaise that have afflicted it in the earliest years of the 21st century. In the months that ensued, before Cardinal Ratzinger's election to the papacy, they developed their ideas into the eloquent dialogue that is *Without Roots* - a book that quickly became an Italian bestseller and is even more timely today than ever. With Europe shaken by the war in Iraq, terrorism, security, Israel, relations with the U.S., immigration, and the rejection of the EU constitution in both France and the Netherlands, the issue of European identity has profound implications for the rest of the world. Bringing together their unique vantage points as leaders of Church and State, Pope Benedict XVI and Pera challenge us to imagine what can be the future of a civilization that has abandoned its history for a relativist secularism. They call on the West to embrace a spiritual rather than political renewal-and to accept the moral beliefs that alone can help us to make sense of changes in technology, economics, and society. Pope Benedict XVI joins the President of the Italian Senate to offer a provocative critique of the spiritual, cultural, and political crisis afflicting the West.

Deep Roots

The lasting effects of slavery on contemporary political attitudes in the American South Despite dramatic social transformations in the United States during the last 150 years, the South has remained staunchly conservative. Southerners are more likely to support Republican candidates, gun rights, and the death penalty, and southern whites harbor higher levels of racial resentment than whites in other parts of the country. Why haven't these sentiments evolved or changed? *Deep Roots* shows that the entrenched political and racial views of contemporary white southerners are a direct consequence of the region's slaveholding history, which continues to shape economic, political, and social spheres. Today, southern whites who live in areas once reliant on slavery—compared to areas that were not—are more racially hostile and less amenable to policies that could promote black progress. Highlighting the connection between historical institutions and contemporary political attitudes, the authors explore the period following the Civil War when elite whites in former bastions of slavery had political and economic incentives to encourage the development of anti-black laws and practices. *Deep Roots* shows that these forces created a local political culture steeped in racial prejudice, and that these viewpoints have been passed down over generations, from parents to children and via communities, through a process called behavioral path dependence. While legislation such as the Civil

Rights Act and the Voting Rights Act made huge strides in increasing economic opportunity and reducing educational disparities, southern slavery has had a profound, lasting, and self-reinforcing influence on regional and national politics that can still be felt today. A groundbreaking look at the ways institutions of the past continue to sway attitudes of the present, *Deep Roots* demonstrates how social beliefs persist long after the formal policies that created those beliefs have been eradicated.

Plant Roots

From Memoria Press: We are often asked if we have a program that includes the study of both Latin and Greek roots. We do now! *Roots of English* is an introduction to English, designed for students as young as third grade, but it is also a great test prep program for older students planning on taking any test with a vocabulary section. Most of the Latin roots covered in this book correspond to the *Latina Christiana* Latin

vocabulary set. The course also introduces Greek roots commonly found in English words. Words with Latin and Greek roots are longer and more difficult than the short words for ordinary objects that form the first layer of an English-speaking child's vocabulary. Their meanings are more nuanced, more specialized. In order to acquire these words and learn how to use them appropriately, a young student needs to understand the meanings of their roots, prefixes, and suffixes. *Roots of English* presents careful analysis of these word elements so that the student learns not only the modern meanings of the words but also their underlying, ancient meanings. Roots of English

Hidden Roots

Umhlonyane, also known as *Artemisia afra*, is one of the oldest and best-documented indigenous medicines in South Africa. This bush, which grows wild throughout the sub-Saharan region, smells and tastes like "medicine," thus easily making its way into people's lives and becoming the choice of everyday healing for Xhosa healer-diviners and Rastafarian herbalists. This "natural" remedy has recently sparked curiosity as scientists search for new molecules against a tuberculosis pandemic while hoping to recognize indigenous medicine. Laplante follows umhlonyane on its trails and trials of becoming a biopharmaceutical — from the "open air" to controlled environments — learning from the plant and from the people who use it with hopes in healing.

Healing Roots

For over a century, plant specialists worldwide have sought to transform healing plants in African countries into pharmaceuticals. And for equally as long, conflicts over these medicinal plants have endured, from stolen recipes and toxic tonics to unfulfilled promises of laboratory equipment and usurped personal patents. In *Bitter Roots*, Abena Dove Osseo-Asare draws on publicly available records and extensive interviews with scientists and healers in Ghana, Madagascar, and South Africa to interpret how African scientists and healers, rural communities, and drug companies—including Pfizer, Bristol-Myers Squibb, and Unilever—have sought since the 1880s to develop drugs from Africa's medicinal plants. Osseo-Asare recalls the efforts to transform six plants into pharmaceuticals: rosy periwinkle, Asiatic pennywort, grains of paradise, *Strophanthus*, *Cryptolepis*, and *Hoodia*. Through the stories of each plant, she shows that herbal medicine and pharmaceutical chemistry have simultaneous and overlapping histories that cross geographic boundaries. At the same time, Osseo-Asare sheds new light on how various interests have tried to manage the rights to these healing plants and probes the challenges associated with assigning ownership to plants and their biochemical components. A fascinating examination of the history of medicine in colonial and postcolonial Africa, *Bitter Roots* will be indispensable for scholars of Africa; historians interested in medicine, biochemistry, and society; and policy makers concerned with drug access and patent rights.

Bitter Roots

As friends began "going back to the land" at the same time that a health issue emerged, Kathleen Alcalá set

out to reexamine her relationship with food at the most local level. Remembering her parents, Mexican immigrants who grew up during the Depression, and the memory of planting, growing, and harvesting fresh food with them as a child, she decided to explore the history of the Pacific Northwest island she calls home. In *The Deepest Roots*, Alcalá walks, wades, picks, pokes, digs, cooks, and cans, getting to know her neighbors on a much deeper level. Wanting to better understand how we once fed ourselves, and acknowledging that there may be a future in which we could need to do so again, she meets those who experienced the Japanese American internment during World War II, and learns the unique histories of the blended Filipino and Native American community, the fishing practices of the descendants of Croatian immigrants, and the Suquamish elder who shares with her the food legacy of the island itself. Combining memoir, historical records, and a blueprint for sustainability, *The Deepest Roots* shows us how an island population can mature into responsible food stewards and reminds us that innovation, adaptation, diversity, and common sense will help us make wise decisions about our future. And along the way, we learn how food is intertwined with our present but offers a path to a better understanding of the future. From ages 10 to 20, Craig Thompson (the author of *Blankets*) and his little brother Phil, toiled in Wisconsin farms. Weeding and harvesting ginseng—an exotic medicinal herb that fetched huge profits in China—funded Craig's youthful obsession with comic books. Ginseng Roots Part One

Since the 2016 presidential election, Americans have witnessed countless stories about Appalachia: its changing political leanings, its opioid crisis, its increasing joblessness, and its declining population. These stories, however, largely ignore black Appalachian lives. Karida L. Brown's *Gone Home* offers a much-needed corrective to the current whitewashing of Appalachia. In telling the stories of African Americans living and working in Appalachian coal towns, Brown offers a sweeping look at race, identity, changes in politics and policy, and black migration in the region and beyond. Drawn from over 150 original oral history interviews with former and current residents of Harlan County, Kentucky, Brown shows that as the nation experienced enormous transformation from the pre- to the post-civil rights era, so too did black Americans. In reconstructing the life histories of black coal miners, Brown shows the mutable and shifting nature of collective identity, the struggles of labor and representation, and that Appalachia is far more diverse than you think.

The Roots of Rap

Between 1944 and 1953, a power struggle emerged between New York governor Thomas Dewey and U.S. senator Robert Taft of Ohio that threatened to split the Republican Party. In *The Roots of Modern*

Conservatism, Michael Bowen reveals how this two-man battle for control of the GOP--and the Republican presidential nomination--escalated into a divide of ideology that ultimately determined the party's political identity. Initially, Bowen argues, the separate Dewey and Taft factions endorsed fairly traditional Republican policies. However, as their conflict deepened, the normally mundane issues of political factions, such as patronage and fund-raising, were overshadowed by the question of what \"true\" Republicanism meant. Taft emerged as the more conservative of the two leaders, while Dewey viewed Taft's policies as outdated. Eventually, conservatives within the GOP organized against Dewey's leadership and, emboldened by the election of Dwight Eisenhower, transformed the party into a vehicle for the Right. Bowen reveals how this decade-long battle led to an outpouring of conservative sentiment that had been building since World War II, setting the stage for the ascendancy of Barry Goldwater and the modern conservative movement in the 1960s.

The Roots of Modern Conservatism

In *Limbo*, award-winning journalist Alfred Lubrano identifies and describes an overlooked cultural phenomenon: the internal conflict within individuals raised in blue-collar homes, now living white-collar lives. These people often find that the values of the working class are not sufficient guidance to navigate the white-collar world, where unspoken rules reflect primarily upper-class values. Torn between the world they were raised in and the life they aspire too, they hover between worlds, not quite accepted in either. Himself the son of a Brooklyn bricklayer, Lubrano informs his account with personal experience and interviews with other professionals living in limbo. For millions of Americans, these stories will serve as familiar reminders of the struggles of achieving the American Dream.

Limbo

This text reveals the importance of radicalism's links to pre-industrial culture and attachments to place and local communities, as well the ways in which journalists who had been pushed out of 'respectable' politics connected to artisans and other workers.

The Roots of Radicalism

In New Mexico—once a Spanish colony, then part of Mexico—Pueblo Indians and descendants of Spanish- and Mexican-era settlers still think of themselves as distinct peoples, each with a dynamic history. At the core of these persistent cultural identities is each group's historical relationship to the others and to the land, a connection that changed dramatically when the United States wrested control of the region from Mexico in 1848.
