Las Vegas

The meteoric rise of Las Vegas from a remote Mormon outpost to an international entertainment center was never a sure thing. In its first decades, the town languished, but when Nevada legalized casino gambling in 1931, Las Vegas met its destiny. This act—combined with the growing popularity of the automobile, cheap land and electricity, and changing national attitudes toward gambling—led to the fantastic casinos and opulent resorts that became the trademark industry of the city and created the ambiance that has made Las Vegas an icon of pleasure. This volume celebrates the city's unparalleled growth, examining both the development of its gaming industry and the creation of an urban complex that over two million people proudly call home. The Official National Hockey League Stanley Cup Centennial Book

In 1957, Congress voted to set up the United States Civil War Centennial Commission. A federally funded agency within the Department of the Interior, the commission's charge was to oversee preparations to commemorate the one-hundredth anniversary of the central event in the Republic's history. Politicians hoped that a formal program of activities to mark the centennial of the Civil War would both bolster American patriotism at the height of the cold war and increase tourism in the South. Almost overnight, however, the patriotic pageant that organizers envisioned was transformed into a struggle over the historical memory of the Civil War and the injustices of racism. In *Troubled Commemoration*, Robert J. Cook recounts the planning, organization, and ultimate failure of this controversial event and reveals how the broad-based public history extravaganza was derailed by its appearance during the decisive phase of the civil rights movement. Cook shows how the centennial provoked widespread alarm among many African Americans, white liberals, and cold warriors because the national commission failed to prevent southern whites from commemorating the Civil War in a racially exclusive fashion. The public outcry followed embarrassing attempts to mark secession, the attack on Fort Sumter, and the South's victory at First Manassas, and prompted backlash against the celebration, causing the emotional scars left by the war to resurface. Cook convincingly

demonstrates that both segregationists and their opponents used the controversy that surrounded the commemoration to their own advantage. Southern whites initially embraced the centennial as a weapon in their fight to save racial segregation, while African Americans and liberal whites tried to transform the event into a celebration of black emancipation. Forced to quickly reorganize the commission, the Kennedy administration replaced the conservative leadership team with historians, including Allan Nevins and a young James I. Robertson, Jr., who labored to rescue the centennial by promoting a more soberly considered view of the nation's past. Though the commemoration survived, Cook illustrates that white southerners quickly lost interest in the event as it began to coincide with the years of Confederate defeat, and the original vision of celebrating America's triumph over division and strife was lost. The first comprehensive analysis of the U.S. Civil War Centennial, *Troubled Commemoration* masterfully depicts the episode as an essential window into the political, social, and cultural conflicts of America in the 1960s and confirms that it has much to tell us about the development of the modern South.

100 Years of Football

Here is an Emerson who knew how to laugh, who was self-doubting as well as self-reliant, and who became the greatest intellectual adventurer of his age. Richardson has, as much as possible, let Emerson speak for himself through his published works, his many journals and notebooks, his letters, his reported conversations. This is not merely a study of Emerson's writing and his influence on others; it is Emerson's life as he experienced it. We see the failed minister, the struggling writer, the political reformer, the poetic liberator. The Emerson of this book not only influenced Thoreau, Fuller, Whitman, Dickinson, and Frost, he also inspired Nietzsche, William James, Baudelaire, Marcel Proust, Virginia Woolf, and Jorge Luis Borges. Emerson's timeliness is persistent and striking: his insistence that literature and science are not separate cultures, his emphasis on the worth of every individual,

his respect for nature. Richardson gives careful attention to the enormous range of Emerson's readings—from Persian poets to George Sand—and to his many friendships and personal encounters—from Mary Moody Emerson to the Cherokee chiefs in Boston—evoking both the man and the times in which he lived. Throughout this book, Emerson's unquenchable vitality reaches across the decades, and his hold on us endures.

The Centennial Book, One Hundred Years of Christian Civilization in Hawaii, 1820-1920

Held in Philadelphia from May 10 through October 10, the 1876 Centennial Exhibition celebrated the 100th anniversary of American independence. Philadelphia hosted 37 nations in five main buildings and 250 additional structures on 285 acres of land. The celebration looked backward to commemorate the progress made over the 100-year period, and it announced to the world that American invention and innovation was on a par with that of our foreign counterparts. Patriotism abounded, as did messages of industrial and commercial prowess that promised a brighter future for all. Over nine million people attended this awesome consumer spectacle, an event that set the tone for a long series of world's fairs yet to come.

Philadelphia's 1876 Centennial Exhibition

In *The Centennial Cure*, the second volume in the *Studies in Atlantic Canada History* series, Meaghan Elizabeth Beaton critically examines the intersection of state policy, cultural development, and commemoration in Nova Scotia during Canada's centennial celebrations. Beaton's engaging and insightful analysis of four case studies—the establishment of the Cape Breton Miners' Museum, the construction of Halifax's Centennial Swimming Pool, the Community Improvement Program, and the 1967 Nova Scotia Highland Games and Folk Festival—reveals the province's attempts to reimagine and renew public spaces. Through these case studies Beaton illuminates the myriad ways in which Nova Scotians saw themselves, in the context of modernity and ethnic identity, during the post-war years. The successes and failures of these infrastructure and cultural projects, intended to foster and develop cultural capital, reflected the socio-economic realities and dreams of local communities. *The Centennial Cure* shifts our focus away from the dominant studies on Expo'67 to provide a nuanced and tension filled account of how Canada's 1967 centennial celebrations were experienced in other parts of Canada.

The 1876 United States Centennial Exhibition in Philadelphia was not only the United States' first important world's fair, it signaled significant changes in the very shape of knowledge. Quarrels between participants in the exhibition represented a greater conflict as the world transitioned between two different kinds of modernity—the Enlightenment of the seventeenth and eighteenth centuries to the High Modern period of the nineteenth and twentieth centuries. At the center of this movement was a shift in the perceived relationship between seeing and knowing and in the perception of what makes an object valuable—its usefulness as a subject of study and learning versus its ability to be bought and sold on the market. Arguments over design of the Centennial reflected these opposing viewpoints. Initial plans were rigidly structured, dividing the exhibits by country and type. But as some exhibitors became more interested in the preferences of their audience, they adopted a more modern stance. Objects traditionally displayed in isolated glass boxes were placed in fictive context—the necklace draped over a mannequin, the vase set on a table in a model room. As a result, the audience could more easily perceive these items as commodities suitable for their own environments and the fair as a place to find ideas for a material lifestyle. Designing the Centennial is a vital first look at the design process and the nature of the display. Bruno Giberti uses official reports of the U.S. Centennial Commission and photographs of the Centennial Photographic Company, as well as the ephemera of the exhibition and literary accounts in books, magazines, and newspapers to illuminate how the 1876 fair revealed changes to come: in future world's fairs, museums, department stores, and in the nature of display itself.
